

Cookies Policy



This Cookies Policy applies to the website(s) operated by **Star Bridge Capital** and/or its affiliated entities, including **SBCFX** (collectively referred to as “**we**”, “**us**”, or “**our**”).

1. Purpose of This Policy

This Cookies Policy explains what cookies are, how and why they are used on our website(s), and the choices available to users regarding their use.

This Policy should be read together with our Privacy Policy, which provides further information on how personal data is processed and protected.

2. What Are Cookies

Cookies are small text files that are placed on a user’s computer, mobile device, or other internet-enabled device when visiting a website. Cookies are widely used to make websites function efficiently, improve user experience, and provide information to website operators.

Cookies do not typically contain information that directly identifies an individual. However, information obtained through cookies may be linked to personal data where permitted by applicable law.

3. Information Collected Through Cookies

The cookies used on our website do **not** store sensitive personal information such as mailing addresses, account passwords, or payment details.

Information collected through cookies may include, among other things:

- Browser type and version
- Device type and operating system
- Language preferences
- Pages visited and time spent on the website
- Login or session status (where applicable)

4. Types of Cookies We Use

4.1 Session and Persistent Cookies

Cookies used on our website may be either:

- **Session Cookies**, which are temporary and are deleted when the browser is closed; or
- **Persistent Cookies**, which remain on the user’s device for a specified period or until deleted.

4.2 Categories of Cookies

We may use the following categories of cookies:

(a) Necessary / Essential Cookies

- **Type:** Session Cookies
- **Administered by:** Us
- **Purpose:**

These cookies are essential for the operation of the website and enable core functionality, such as security, authentication, and access to secure areas. Without these cookies, certain services or features may not function properly.

(b) Functionality Cookies

- **Type:** Persistent Cookies
- **Administered by:** Us
- **Purpose:**

These cookies allow the website to remember user preferences and settings, such as language selection or login status, in order to provide a more personalised and efficient user experience.

5. Third-Party Cookies

Some cookies on our website may be placed by third-party service providers (for example, analytics, advertising, or technical service providers). We do not control or have access to such third-party cookies.

The use of third-party cookies is subject to the privacy and cookies policies of the relevant third parties.

6. Your Choices and Cookie Management

Users may manage or disable cookies through their browser settings at any time. Please note that disabling cookies may affect the functionality or availability of certain features of the website, particularly secure or personalised areas.
