# Privacy Policy

SBCFX is the business name of Star Bridge Capital Global Group LLC (referred to as "the Company", "us", "we", "our", or "ourselves" as applicable). The Company is authorized and regulated by the Financial Services Authority of St. Vincent and the Grenadines under registration number 4343 LLC 2025. It is registered in St. Vincent and the Grenadines, with its office located at Griffith Corporate Centre, Beachmont, Kingstown, St. Vincent and the Grenadines, P.O. Box 1510.

This Privacy Policy applies to our main website and any other related websites registered and operated by SBCFX.

### **Application**

To open an account with SBCFX, you must complete and submit an application form along with the required documents. The application form requests personal information to enable SBCFX to evaluate your application and comply with applicable laws and regulations governing our services. This information is also used to contact you regarding our trading services.

The Company will not disclose any client's confidential information to third parties unless required by a competent legal authority. Any such disclosure will be made strictly on a 'need-to-know' basis, unless otherwise directed by the authority. In these cases, SBCFX will explicitly inform the third party of the confidential nature of the information.

Clients acknowledge and agree that SBCFX may periodically engage companies under contract for statistical purposes to improve the Firm's marketing. Consequently, some or all of a client's personal data may be disclosed, but only on an anonymous and aggregated basis.

### **Agents**

We use payment processing companies to handle deposits to and withdrawals from your account. These companies do not retain, share, store, or use personally identifiable information for any other purposes.

## Privacy

Our website tracking systems may collect data about the pages you access, how you found our website, your visit frequency, and similar details. When you visit our website, we may log your IP address. However, your IP address identifies only the general geographic area of your connection, not you personally. The information gathered is used to improve our website's content and may be used by us to contact you through appropriate means and provide information we believe may be of interest to you.

We may set a persistent cookie for statistical purposes. Persistent cookies also help us track and understand user locations and interests to enhance your experience on our website.

Some business partners may use cookies on our site. We have no access to or control over these cookies.

## **Security and Protection of Your Personal Information**

Personal information provided when registering as a user of our website or services is classified as Registration Information. It is stored securely on protected servers accessible only to authorized personnel via password. SBCFX encrypts all personal information during transfer and takes all necessary measures to prevent unauthorized access.

Other personal information provided to SBCFX (non-Registration Information) is also stored on secure servers and accessible only to authorized personnel via password. This information is not accessible online by you, and no password can be set to view or modify it.

SBCFX does not license, sell, lease, or otherwise disclose your personal information to affiliates or third parties unless required by law or as part of a business transfer agreement.
